WHAT IS A "CORRESPONDENT"?

Correspondents are members of the National Academy of Sciences, National Academy of Engineering, and National Academy of Medicine who elect to be kept informed of the CHR's events and activities.

Roughly 1,500 members of the Academies serve as CHR Correspondents.

CORRESPONDENTS:

- -receive periodic email alerts on relevant events. volunteering opportunities, and other initiatives at the intersection of human rights and science, technology, and health
- -gain access to the CHR's private annual report and other confidential updates on the CHR's work
- -are alerted to the situations of colleagues under threat and provided fast-response options to support them through the CHR's Action Alert system
